Dear **Speaker Belmonte**,

This pertains to the implementation of Section 14 of Republic Act No. 7166, specifically the second paragraph thereof, which reads:

*“Sec. 14. Statement of Contributions and Expenditures; Effect of Failure to File Statement. - Every candidate and treasurer of the political party shall, within thirty (30) days after the day of the election, file in duplicate with the offices of the Commission the full, true and itemized statement of all contributions and expenditures in connection with the election.*

No person elected to any public office shall enter upon the duties of his office until he has filed the statement of contributions and expenditures herein required.

x x x.” (Underscoring supplied)

After checking the campaign submissions of the winning candidates for Members of the House of Representatives, this Commission has found several elected Members who had failed to submit their campaign finance disclosure statements in relation to the 13 May 2013 National and Local Elections. A listing of those who failed to file their Statements of Contributions and Expenditures (SOCEs) is attached to this letter for your reference.
