Dear **Secretary Roxas**,

This pertains to the implementation of Section 14 of Republic Act No. 7166 ("RA 7166"), on which subject this Commission entered into a Memorandum of Agreement (MOA) with the Department of the Interior and Local Government (DILG) last 14 March 2012. A copy of this MOA is attached to this letter for your reference.

Pursuant to the said MOA, the undersigned, as the Chairperson of the Campaign Finance Steering Committee, is submitting the attached list of candidates who have failed to submit their campaign finance disclosure statements in relation to the 13 May 2013 National and Local Elections. The second paragraph of Section 14 of RA 7166 reads:

"Sec. 14. Statement of Contributions and Expenditures; Effect of Failure to File Statement. - Every candidate and treasurer of the political party shall, within thirty (30) days after the day of the election, file in duplicate with the offices of the Commission the full, true and itemized statement of all contributions and expenditures in connection with the election.

No person elected to any public office shall enter upon the duties of his office until he has filed the statement of contributions and expenditures herein required.

x x x." (Underscoring supplied)
